- 2. If my son/daughter/ward is found to be indiscipline, violates university/hostel rules, or is found to be medically or mentally unfit (a condition not disclosed at the time of admission), I shall not claim or request any refund of fees or charges upon termination or removal from the University.
- 3. In the event of any mishap during sports, trekking, picnic, local travel, or other similar activities (including acts of God), I shall not hold the Graphic Era University authority/management responsible for any claims. I shall also bear all expenses incurred by the University in providing medical treatment to my ward.
- 4. I shall ensure that all dues are cleared in advance before the commencement of each term.
- 5. My son/daughter will not be permitted to visit the authorized local guardian overnight unless written consent is provided by me.
- 6. Any damages caused by my ward to hostel property will be charged as per the actual cost of the item(s) damaged. If the damage cost exceeds the caution money deposited, the hostel authorities are authorized to take appropriate action to recover the remaining amount.

The hostel authorities reserve the right to seize such items, and any item seized shall not be returned.
- 8. My ward shall not consume alcohol, drugs, or smoke within the hostel premises. Violation of this rule may lead to **termination of hostel residency without any refund**.
- 9. I understand that the hostel authority shall not be responsible for any loss or damage to my ward's personal belongings.
- 10. My ward shall ensure that all valuables are stored safely inside the wardrobes during holidays to allow the administration to use the room in case of an emergency.
- 11. The hostel authorities shall not be held responsible if my ward is found to be suffering from Covid-19 or any other communicable disease while residing in the hostel/university premises.
